Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to 0 tCO₂e, a 0%ge reduction against the 2021 baseline and the measures will be in effect when performing the contract. Valiant Integrated Services Ltd., has had nil emissions.

On commencement of operations in the UK, Valiant Integrated Services Ltd. intends to implement use of LED/PIR lighting in any facility we lease or own. Further Valiant Integrated Services Ltd., will encourage all employees to use public transportation to the greatest extent possible. Once it begins work in the UK, the Company will seek further methods to reduce its carbon footprint.
